LOAN INTERVIEW CHECKLIST

- Centrelink "Income" and "Deduction" statements
 (Should be less than two weeks old) or pay slips (two most recent pay slips)

 Centrelink Health Care card/Pension card, and Driver's license

 Rental statement or lease agreement with evidence of up—to-date rental payment. If you are not on the lease agreement, get a statutory declaration or a letter from the person to whom you pay the boarding with clear information on how much you pay towards rent and utilities and how long you have lived at that address

 Most recent gas, electricity, water and telephone bills and evidence of payments

 Last 90 days bank statement of all your accounts which includes credit cards and other loans if any

 A quote for the item you intend to buy
